What is domestic violence and harassment?

Domestic violence and harassment take many forms. For example, physical assault, rape, sexual abuse and intimidation as well as mental and verbal abuse. It is not uncommon for people to be afraid to ask for help.

Offenders may include existing partners, ex partners, relatives or unrelated parties. Domestic violence affects people of all ages, race, gender or sexuality.

What action can I take?

Where domestic violence or harassment is inflicted by an existing partner, former partner, a relative or an unrelated person, it is possible to apply to the Court for an Order that the domestic violence or harassment should stop. The Order will also state that violence, threats of violence or harassment should not take place in the future. The Order can protect you and your children and is called a Non Molestation Order.

The Court may, where appropriate, order the person responsible for the violence or harassment to leave a marital or co-habital home. The Court also has the power to prevent them from returning. This is called an Occupation Order.

The Court can order those who have been excluded from the home to pay specific household bills.

What do I have to prove?

It is necessary to show that violence has been threatened, suffered or harassment has taken place and there is a risk of "significant harm" towards you or your children. The strongest cases are those where there has been an act of violence in recent weeks.

If a person against whom an Order has been made fails to comply with it you should notify the police immediately. The police have the power to charge the individual concerned with criminal offences and take the case to Court. This may result in criminal convictions, the penalties for which include a fine or imprisonment.

It is also possible for the police to charge an individual with offences under the Protection from Harassment Act 1997. Again this may result in criminal proceedings being taken. The Court has the power to make a Non Molestation Order (Injunction Order) within such proceedings.

What about the cost?

We can immediately assess whether you are entitled to public funding (Legal Aid). In doing so we must consider your current income and the merits of the case. If you are eligible for public funding you may be required to make monthly contributions to the Legal Services Commission. At your initial appointment you will be asked to provide identification and a proof of income for this purpose.

If you are not sure whether you are eligible for public funding, do not worry. We are happy to provide an initial interview free of charge.

How long does it take?

In emergency cases we will offer you an appointment the same day. Otherwise we will try and arrange an appointment for you within 24 hours of your telephone call to us (Monday to Friday).

If an assault takes place at the weekend you should contact your local police station immediately.

In serious cases we can go to Court the same day or the following day.
